

OFFICIAL RULES FOR CASH POP 50% BONUS HOURS
Effective January 1, 2021

The New Jersey Lottery is conducting a CASH POP 50% Bonus Hours promotion (“CASH POP Bonus Hours Promotion”), whereby players who purchase five (5) numbers (pops) or more of CASH POP on a single CASH POP ticket between the hours of approximately 5 p.m. and 7 p.m. on Thursdays and Fridays in January, February, and March 2021 are eligible for a chance at 50% increased prizes.

1. The Promotion Period for the CASH POP Bonus Hours Promotion is defined as: Thursdays and Fridays between the hours of approximately 5 p.m. to 7 p.m. in January, February, and March 2021 (the “Promotion Period”), as set forth in the following schedule:

2. The CASH POP Bonus Hours Promotion is offered at all New Jersey Lottery licensed retail locations during the Promotion Period.
3. Players must be 18 years or older to play and participate in the CASH POP Bonus Hours Promotion. Persons prohibited from purchasing New Jersey Lottery tickets or shares pursuant to N.J.S.A. 5:9-16 and N.J.A.C. 17:20-1.3 are prohibited from playing or participating in the CASH POP Bonus Hours Promotion.
4. Players (sometimes referred to as “you” or “your” or “players”) who purchase five (5) numbers or more of CASH POP a single CASH POP ticket during the Promotion Period are eligible for a chance at 50% increased prizes.
5. During the Promotion Period, the following ticket message (“Ticket Message”) will be printed on tickets printed by the New Jersey Lottery’s Gaming System as a result of a CASH POP wager(s) consisting of five (5) numbers (pops) or more of CASH POP on a single CASH POP ticket (“Eligible Purchase”):

A ticket printed as a result of an Eligible Purchase that displays the Ticket Message will qualify for the CASH POP Bonus Hours Promotion. If an Eligible Purchase consists of more than one (1) consecutive drawing (“Multidraw”) and the ticket that prints as a result of such an Eligible Purchase displays the Ticket Message, that ticket will qualify for the CASH POP Bonus Hours Promotion for all applicable draw #s listed on that particular ticket. If a ticket printed as a result of an Eligible Purchase and displaying the Ticket Message validates as a winning ticket through the New Jersey Lottery’s Gaming System, the Player will receive 50% increased prizes on that particular ticket subject to these Official Rules. A Player with a ticket printed as a result of an Eligible Purchase consisting of Multidraw, which displays the Ticket Message and validates as a winning ticket through the New Jersey Lottery’s Gaming System, may receive an exchange ticket from a New Jersey Lottery licensed retailer which displays the Ticket Message, and which will be eligible for any remaining, subsequent draw #s listed on the exchange ticket from the original purchase. The Ticket Message alone on a ticket printed as a result of an Eligible Purchase does not denote a win or a winning ticket. The New Jersey Lottery reserves the right to modify the Ticket Message at any time and without notice.

6. The New Jersey Lottery may declare any ticket printed as a result of an Eligible Purchase void if it is damaged or stolen.
7. The New Jersey Lottery reserves the right to adjust, make exceptions for and disqualify New Jersey Lottery licensed retailers from participating in the CASH POP Bonus Hours Promotion at any time during the Promotion Period as deemed necessary by the New Jersey Lottery, in its discretion, to ensure the integrity of the CASH POP Bonus Hours Promotion and/or when such action is determined by the New Jersey Lottery, in its discretion, to be in the best interest of the New Jersey Lottery.
8. The New Jersey Lottery reserves the right, without prior notice, to cancel, terminate, modify or suspend the CASH POP Bonus Hours Promotion at any time and for any reason, including but not limited to if the New Jersey Lottery determines that a virus, bug, unauthorized human intervention, fraud or other cause beyond its control has or is corrupting or affecting the administration, security, fairness or proper conduct of the CASH POP Bonus Hours Promotion.
9. By participating in the CASH POP Bonus Hours Promotion, you agree to forever waive, discharge, indemnify and release the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, commissioners, officers, directors, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees and each of their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and

any and all other companies associated with the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, from any and all liability, injury, damage, death, litigation, claim, cause of action or loss that may occur, directly or indirectly, whether known or unknown, and whether caused by negligence or not, arising out of or associated with your participation in the CASH POP Bonus Hours Promotion, your acceptance, possession, use or misuse of any prize awarded in connection with the CASH POP Bonus Hours Promotion, any defect with the CASH POP Bonus Hours Promotion, and/or any error in the administration or operation of the CASH POP Bonus Hours Promotion. You, on behalf of yourself and/or your spouse, heirs, executors, administrators, representatives, successors, assigns and next of kin, waive all claims for damages, injuries and/or death, whether known or unknown, and whether caused by negligence or not, sustained to you or your property that you may have against the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, commissioners, officers, directors, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees and each of their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, arising out of or associated with your participation in the CASH POP Bonus Hours Promotion, your acceptance, possession, use or misuse of any prize awarded in connection with the CASH POP Bonus Hours Promotion, any defect with the CASH POP Bonus Hours Promotion, and/or any error in the administration or operation of the CASH POP Bonus Hours Promotion.

10. Pursuant to the New Jersey Lottery Law (N.J.S.A. 5:9-1 et seq. and N.J.A.C. 17:20-1.1 et seq.), holders of winning New Jersey Lottery tickets or shares may choose to remain anonymous indefinitely. The identity of a holder choosing to remain anonymous shall not be included under materials available for public inspection pursuant to the New Jersey Open Public Records Act (N.J.S.A. 47:1A-1 et seq. and N.J.A.C. 17:20-7.7). Holders of winning tickets or shares may expressly authorize use by or on behalf of the New Jersey Lottery of his or her name, address, prize amount and photographic or videographic likeness, in any medium for the sole purpose of advertising and publicity.
11. By participating in the CASH POP Bonus Hours Promotion, retailers and Players agree to fully comply with these Official Rules for CASH POP 50% Bonus Hours and to accept the decisions of the New Jersey Lottery or its designee as final and binding with regard to the CASH POP Bonus Hours Promotion.
12. The CASH POP Bonus Hours Promotion is governed by the State Lottery Law, N.J.S.A. 5:9-1 through -25, and the Rules of the Lottery Commission, N.J.A.C. 17:20-1.1 through -12.23. The New Jersey Lottery Executive Director has the sole authority to resolve disputes. The New Jersey Lottery Executive Director's decision regarding any disputes shall be final.

13. These Official Rules for CASH POP 50% Bonus Hours may be changed at any time without prior notice if determined by the New Jersey Lottery or its designee to be in the best interests of the New Jersey Lottery.
14. All winners, tickets and transactions in connection with the CASH POP Bonus Hours Promotion are subject to New Jersey Lottery Rules and Regulations and State law. All prizes awarded in connection with the CASH POP Bonus Hours Promotion are subject to claim procedures, validation tests and other applicable requirements of the New Jersey Lottery. Liability for void or nonconforming ticket, if any, is limited to replacement of ticket with un-played ticket. The New Jersey Lottery is not responsible for lost or stolen tickets. The CASH POP Bonus Hours Promotion is void where otherwise prohibited or restricted by law. This CASH POP Bonus Hours Promotion is not valid in combination with any other New Jersey Lottery promotion or coupon.
15. Winners are solely responsible for payment of all applicable federal, State and local taxes associated with any prize awarded in connection with the CASH POP Bonus Hours Promotion.
16. Overall CASH POP odds vary based on the amount of numbers played, for detailed information see Odds and Prizes at NJLottery.com/CASHPOP.
17. The invalidity or unenforceability of any provision of these Official Rules for CASH POP 50% Bonus Hours will not affect the validity or enforceability of any other provision of these Official Rules. In the event that any provision of these Official Rules for CASH POP 50% Bonus Hours is determined to be invalid or otherwise unenforceable or illegal, in whole or in part, the other provisions will remain in full force and effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained therein. The failure to enforce any provision of these Official Rules for CASH POP 50% Bonus Hours will not constitute a waiver of that or any other provision of these Official Rules.
