

**OFFICIAL RULES FOR QUICK DRAW Doubler Days**  
**Effective January 1, 2021**

The New Jersey Lottery is conducting a Quick Draw Doubler Days promotion (“Quick Draw Doubler Days Promotion”) whereby winning Quick Draw or Quick Draw with BULLSEYE tickets purchased anytime during the Promotion Period (as defined herein) may qualify for a chance at doubled prizes.

1. The Promotion Period for the Quick Draw Doubler Days Promotion is defined as: approximately 05:00 AM January 1, 2021 – approximately 02:00 AM April 1, 2021 (the “Promotion Period”).
2. The Quick Draw Doubler Days Promotion is offered at all New Jersey Lottery licensed retail locations during the Promotion Period.
3. Players must be 18 years or older to play and participate in the Quick Draw Doubler Days Promotion (referred to herein as “Players” “you” or “your”). Persons prohibited from purchasing New Jersey Lottery tickets or shares pursuant to N.J.S.A. 5:9-16 and N.J.A.C. 17:20-1.3 are prohibited from playing or participating in the Quick Draw Doubler Days Promotion.
4. During the Promotion Period, the following ticket message (“Ticket Message”) will be printed on every 15<sup>th</sup> ticket (“Random Value”) printed by the New Jersey Lottery’s Gaming System as a result of a Quick Draw or Quick Draw with BULLSEYE wager(s) (“Eligible Purchase”) purchased across all participating New Jersey Lottery licensed retail locations:

DOUBLER DOUBLER DOUBLER!  
THIS TICKET QUALIFIES  
FOR DOUBLE THE PRIZES  
IF IT IS A WINNER.

A ticket printed as a result of an Eligible Purchase that displays the Ticket Message will qualify for the Quick Draw Doubler Days Promotion. If an Eligible Purchase consists of more than one (1) consecutive drawing (“Multidraw”) and the ticket that prints as a result of such an Eligible Purchase displays the Ticket Message, that ticket will qualify for the Quick Draw Doubler Days Promotion for all applicable draw #s listed on that particular ticket. If a ticket printed as a result of an Eligible Purchase and displaying the Ticket Message validates as a winning ticket through the New Jersey Lottery’s Gaming System, the Player will receive double the prize won on that particular ticket, subject to these Official Rules for Quick Draw Doubler Days. A Player with a ticket printed as a result of an Eligible Purchase consisting of Multidraw, which displays the Ticket Message and validates as a winning ticket through the New Jersey Lottery’s Gaming System, may receive an exchange ticket from a New Jersey Lottery licensed retailer which displays the Ticket Message, and which will be eligible for any remaining, subsequent draw #s listed on the exchange ticket from the original purchase. The Ticket Message alone on a ticket printed as a result of an Eligible Purchase does not denote a win or a winning ticket. The New

Jersey Lottery reserves the right to change or modify the Random Value and/or the Ticket Message at any time, for any reason, and without prior notice.

5. The New Jersey Lottery may declare any ticket printed as a result of an Eligible Purchase void if it is damaged or stolen.
6. The New Jersey Lottery reserves the right to adjust, make exceptions for and disqualify New Jersey Lottery licensed retailers from participating in the Quick Draw Doubler Days Promotion at any time and without prior notice during the Promotion Period as deemed necessary by the New Jersey Lottery, in its discretion, to ensure the integrity of the Quick Draw Doubler Days Promotion and/or when such action is determined by the New Jersey Lottery, in its discretion, to be in the best interest of the New Jersey Lottery.
7. The New Jersey Lottery reserves the right, without prior notice, to cancel, terminate, modify or suspend the Quick Draw Doubler Days Promotion at any time and for any reason, including but not limited to if the New Jersey Lottery determines that a virus, bug, unauthorized human intervention, fraud or other cause has or is corrupting or affecting the administration, security, fairness or proper conduct of the Quick Draw Doubler Days Promotion.
8. By participating in the Quick Draw Doubler Days Promotion, you agree to forever waive, discharge, indemnify and release the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, officers, commissioners, directors, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees and each of their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, from any and all liability, injury, damage, death, litigation, claim, cause of action or loss that may occur, directly or indirectly, whether known or unknown, and whether caused by negligence or not, arising out of or associated with your participation in the Quick Draw Doubler Days Promotion, your acceptance, possession, use or misuse of any prize awarded in connection with the Quick Draw Doubler Days Promotion, any defect with the Quick Draw Doubler Days Promotion, and/or any error in the administration or operation of the Quick Draw Doubler Days Promotion. You, on behalf of yourself and/or your spouse, heirs, executors, administrators, representatives, successors, assigns and next of kin, waive all claims for damages, injuries and/or death, whether known or unknown, and whether caused by negligence or not, sustained to you or your property that you may have against the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, commissioners, officers, directors, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees and each of their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, arising out of or associated with your participation in the Quick Draw Doubler Days Promotion, your acceptance, possession, use or misuse of any prize awarded

in connection with the Quick Draw Doubler Days Promotion, any defect with the Quick Draw Doubler Days Promotion, and/or any error in the administration or operation of the Quick Draw Doubler Days Promotion.

9. Pursuant to the New Jersey Lottery Law (N.J.S.A. 5:9-1 et seq. and N.J.A.C. 17:20-1.1 et seq.), holders of winning New Jersey Lottery tickets or shares may choose to remain anonymous indefinitely. The identity of a holder choosing to remain anonymous shall not be included under materials available for public inspection pursuant to the New Jersey Open Public Records Act (N.J.S.A. 47:1A-1 et seq. and N.J.A.C. 17:20-7.7). Holders of winning tickets or shares may expressly authorize use by or on behalf of the New Jersey Lottery of his or her name, address, prize amount and photographic or videographic likeness, in any medium for the sole purpose of advertising and publicity.
10. By participating in the Quick Draw Doubler Days Promotion, retailers and Players agree to fully comply with these Official Rules for Quick Draw Doubler Days and to accept the decisions of the New Jersey Lottery or its designee as final and binding with regard to the Quick Draw Doubler Days Promotion.
11. The Quick Draw Doubler Days Promotion is governed by the State Lottery Law, N.J.S.A. 5:9-1 through -25, and the Rules of the Lottery Commission, N.J.A.C. 17:20-1.1 through -12.23. The New Jersey Lottery Executive Director has the sole authority to resolve disputes. The New Jersey Lottery Executive Director's decision regarding any disputes shall be final.
12. These Official Rules for Quick Draw Doubler Days may be changed at any time without prior notice if determined by the New Jersey Lottery or its designee to be in the best interests of the New Jersey Lottery.
13. All winners, tickets and transactions in connection with the Quick Draw Doubler Days Promotion are subject to New Jersey Lottery Rules and Regulations and State law. All prizes awarded in connection with the Quick Draw Doubler Days Promotion are subject to claim procedures, validation tests and other applicable requirements of the New Jersey Lottery. Liability for void or nonconforming ticket, if any, is limited to replacement of ticket with un-played ticket. The New Jersey Lottery is not responsible for lost or stolen tickets. The Quick Draw Doubler Days Promotion is void where otherwise prohibited or restricted by law. This Quick Draw Doubler Days Promotion is not valid in combination with any other New Jersey Lottery promotion or coupon. To the extent the Quick Draw Doubler Days promotion is running concurrently with a Quick Draw Bonus Hours promotion, the Quick Draw Bonus Hours promotion will take precedent and be the promotion of record for that wager.
14. Winners are solely responsible for payment of all applicable federal, State and local taxes associated with any prize awarded in connection with the Quick Draw Doubler Days Promotion.
15. Odds for a Player to receive the Ticket Message displayed on ticket printed as a result of an Eligible Purchase made during the Promotion Period are based on all Quick Draw and Quick Draw with BULLSEYE wagers system wide across all participating New Jersey Lottery licensed retail locations

and the Random Value (as defined and described in Paragraph 4 of these Official Rules) set by the New Jersey Lottery in connection with the Quick Draw Doubler Days Promotion. Overall Quick Draw and Quick Draw with BULLSEYE odds vary based on the amount of numbers played, for detailed information see Odds and Prizes at [NJLottery.com/QuickDraw](http://NJLottery.com/QuickDraw).

16. The invalidity or unenforceability of any provision of these Official Rules for Quick Draw Doubler Days will not affect the validity or enforceability of any other provision of these Official Rules. In the event that any provision of these Official Rules for Quick Draw Doubler Days is determined to be invalid or otherwise unenforceable or illegal, in whole or in part, the other provisions will remain in full force and effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained therein. The failure to enforce any provision of these Official Rules for Quick Draw Doubler Days will not constitute a waiver of that or any other provision of these Official Rules.
17. Subject to New Jersey Lottery Rules, "Official Game Rules Quick Draw" (Effective October 1, 2018) and "Addendum Official Game Rules Quick Draw Game Rules Bullseye" (Effective October 1, 2018), a prize amount won in connection with the Quick Draw Doubler Days Promotion may be pari-mutuel. The total liability for the 10 of 10 prize in connection with the Quick Draw Doubler Days Promotion is limited to and shall not exceed \$3,000,000 per drawing.
