

## NEW JERSEY LOTTERY TELL US YOUR LOTTERY STORY WAIVER AND RELEASE

As a condition of participating in and/or entering the New Jersey Lottery Tell Us Your Lottery Story, I hereby grant the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, representatives and designees (sometimes collectively referred to as "Lottery"), the irrevocable right and permission to record me and/or my New Jersey Lottery Story using recording devices of any kind, including but not limited to film, videotape, photograph, live stream, audiovisual technology and all other mediums, media and/or technology now available or hereafter developed. I hereby grant the Lottery the irrevocable right to use, exploit, edit, alter, copy, exhibit, distribute, broadcast, publish, reproduce, and/or otherwise globally disseminate (collectively "Use"), throughout the world in perpetuity, such recording(s) of me, my image, voice, likeness, name, biographical information, town and state of residence, prize (if any), and/or my New Jersey Lottery Story (collectively "Image"), in whole or in part, distorted, altered, modified, and/or adapted in character and/or in form, alone and/or accompanied by other material, in all media and materials, whether now known or hereafter developed, including without limitation, the Internet, social media platforms, television, cable, radio, print, publications, books, audiovisual and/or multi-media, without payment of royalty(ies), fee(s), credit(s) or any other compensation to me, and without inspection or approval of Use by me, for purposes of publicizing, advertising and promoting the New Jersey Lottery or for any other lawful purpose.

I hereby agree to forever waive, discharge, indemnify and release the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, officers, directors, commissioners, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees, and each of their respective parent companies, affiliated companies, subsidiaries, licensees, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, from any and all liability, injury, damage, death, litigation, claim, cause of action and/or loss that may occur, directly or indirectly, whether known or unknown, and whether caused by negligence or not, arising out of or associated with my participation and/or entry in the New Jersey Lottery Tell Us Your Story.

By clicking the box on the New Jersey Lottery Website indicating "I have read, understand and consent to the terms of the New Jersey Lottery's Waiver and Release", I hereby consent to be fully bound by the terms and conditions of this New Jersey Lottery Tell Us Your Lottery Story Waiver and Release. I understand that the New Jersey Lottery Law (N.J.S.A. 5:9-1 et seq. and N.J.A.C. 17:20-1.1 et seq.) ("New Jersey Lottery Law") allows the holders of winning New Jersey Lottery tickets or shares to choose to remain anonymous, and to the extent this applies to the New Jersey Lottery Tell Us Your Lottery Story in which I am participating or entering, by clicking the box on the New Jersey Lottery Website indicating "I have read, understand and consent to the terms of the New Jersey Lottery's Waiver and Release", I hereby knowingly waive my right to remain anonymous under the New Jersey Lottery Law.

I hereby certify that I am at least 18 years of age and competent to contract in my own name, and that my clicking of the box on the New Jersey Lottery Website indicating "I have read, understand and consent to the terms of the New Jersey Lottery's Waiver and Release" is based upon good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged.
